****1. Introduction****

Upon full payment for services rendered, clients are granted a non-exclusive, non-transferable, revocable license to use the delivered content for personal, non-commercial purposes only, unless otherwise agreed in writing. Clients shall not claim any proprietary rights in the content nor use it for resale, commercial purposes, or alter it without express written permission from Aeries Aperture.

****4. Services****

Our services are customized and carried out in accordance with the specific agreements made with each client. We strive to deliver the content that reflects the client's requirements and the artistic direction of Aeries Aperture.

****5. Warranties****

Aeries Aperture disclaims all warranties, express or implied, to the extent allowed by law. This includes, but is not limited to, implied warranties of merchantability, non-infringement, and fitness for a particular purpose. ****6. Cancellation and Refund Policy****

If any part of these Terms is found to be unenforceable or invalid, that part will be limited or eliminated to the minimum extent necessary. The remainder of the Terms will remain in full force and effect.

****11. Termination of Service****

Aeries Aperture reserves the right to terminate a contract for services if a client violates these Terms, infringes on intellectual property rights, or engages in conduct that is detrimental to Aeries Aperture or its interests.

These Terms are governed by the laws of King County, Washington, USA, without regard to its conflict of laws principles.
