

****Aeries Aperture Terms and Conditions for Print on Demand Goods****

****1. Introduction****

Welcome to Aeries Aperture's print on demand shop. By purchasing our print on demand products, you are agreeing to be bound by the following terms and conditions ("Terms of Service"). These Terms of Service apply to all users of the site, including without limitation users who are browsers, vendors, customers, merchants, and/ or contributors of content.

****2. General Conditions****

We reserve the right to refuse service to anyone for any reason at any time. You understand that your content (not including credit card information), may be transferred unencrypted and involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices.

****3. Intellectual Property Rights****

All graphics, images, designs, and intellectual property displayed on products sold by Aeries Aperture or through AeriesAperture.com are the exclusive property of Aeries Aperture. Customers are granted a non-exclusive, non-transferable, revocable license to use the products purchased for personal, non-commercial purposes only. Customers shall not claim ownership, offer for resale, alter, reproduce, create derivative works from, or otherwise use any of Aeries Aperture's artwork without express written permission from Aeries Aperture.

****4. Products****

Our products are custom-made and printed upon order using third-party print on demand vendors. We have made every effort to display as accurately as possible the colors and images of our products that appear at the store. We cannot guarantee that your computer monitor's display of any color will be accurate. Additionally, we guarantee any aspect of the third-party vendors' services, including but not limited to the quality of goods, printing services, or timing of deliveries.

****5. Warranties****

Aeries Aperture disclaims all warranties, express or implied, including, but not limited to, implied warranties of merchantability and fitness for a particular purpose to the extent allowed by law. Aeries Aperture does not warrant that the products sold, Aeries Aperture's services, information, or other material purchased or obtained by you will meet your expectations or that any errors in the Service will be corrected.

****6. Return and Refund Policy****

Due to the custom nature of these products, we maintain a strict no-return and no-refund policy for customer ordering errors, including but not limited to the selection of wrong size, color, or change of mind.

In the case of a damaged product or a manufacturing error, Aeries Aperture will provide a free replacement or a refund provided the customer contacts us within 14 days of product delivery. To initiate a return or request a refund, the customer must complete a "Claim Form" (see Refund Policy document) and provide clear photographic evidence of the issue.

For products with manufacturing errors affecting multiple items with the same design, a photograph or video of all affected items must be submitted for confirmation.

Items that are customized, personalized, on sale, or marked as "final sale" or "non-returnable" at the time of purchase are not eligible for return or refund. If the issue is a non-delivery, the customer may opt for a replacement at an additional charge or a partial refund.

All return and refund requests will be processed and investigated in accordance with this policy. Minor variations in product production, such as print placement within a tolerance of 0.5 inches, will not be eligible for return or refund as these are not considered defects.

****7. Limitation of Liability****

To the maximum extent permitted by law, Aeries Aperture shall not be liable for any damages of any kind arising from the use of our print on demand goods services, including, but not limited to direct, indirect, incidental, punitive, and consequential damages. In no case shall Aeries Aperture, our directors, officers, employees, affiliates, agents, contractors, interns, suppliers, service providers, or licensors be liable for any injury, loss, claim, or any direct, indirect, incidental, punitive, special, or consequential damages of any kind.

****8. Product Liability****

If, at our request, you send certain specific submissions or without a request from us you send creative ideas, suggestions, proposals, plans, or other materials, whether online, by email, by postal mail, or otherwise, you agree that we may, at any time, without restriction, edit, copy, publish, distribute, translate and otherwise use in any medium any comments that you forward to us.

****12. Errors, Inaccuracies, and Omissions****

Occasionally there may be information on our site or in the Service that contains typographical errors, inaccuracies, or omissions that may relate to product descriptions, pricing, promotions, offers, product shipping charges, transit times, and availability.

****13. Prohibited Uses****

****14. Indemnification****

****17. Dispute Resolution****

Any dispute or claim relating in any way to your use of any Aeries Aperture service, or to any products sold or distributed by Aeries Aperture or through AeriesAperture.com will be resolved by binding arbitration, rather than in court, except that you may assert claims in small claims court if your claims qualify. The arbitration will be conducted in King County, Washington, and judgment on the arbitration award may be entered into any court having jurisdiction thereof.

****18. Severability****

If any provision of these Terms and Conditions is determined to be unlawful, void, or unenforceable, such provision shall nonetheless be enforceable to the fullest extent permitted by applicable law, and the unenforceable portion shall be deemed to be severed from these Terms and Conditions. Such determination shall not affect the validity and enforceability of any other remaining provisions.
